Arrow Creek Hazardous Fuels Reduction

Project Purpose

This project will improve the fire safety for the community of Arrow Creek in southwest Reno, Nevada. At least 178 acres will be treated to enhance the protection of life and property from catastrophic wildfire as well as maintain sustainable fresh water supplies for municipal, agricultural, and wildlife use.

Project Treatments

Hazardous fuel reduction through thinning of brush species and decreasing flammable annual grasses will be implemented in open spaces throughout the community using mechanical, chemical and biological techniques. Masticators will be used by contractors to thin the brush, and a combination of selective herbicides and seeding will be used to decrease cheatgrass. Hazardous fuels loads will be reduced from 10 tons/acre to 3 tons/acre

Anticipated Impacts & Outcomes

Treatment implementation may cause temporary, short-term [negative or positive] impacts to residents in these ways:

Short-term benefits include decreased hazardous fuels loads and impacts include some dust, soil exposure, and public education of fire adapted principles including defensible space maintenance practices.

Long-term anticipated outcomes include the Arrow Creek taking significant steps toward becoming a fire adapted community.

Threats and Risks to the Area

ArrowCreek encompasses ~3,200 acres and has an 8.5 mile perimeter around the community, along with 1,700 County-owned acres of open space that surrounds the community on 3 sides. This condition, combined with the potential human and natural wildfire ignitions and regular Zephyr winds, creates a potential calamitous events whereby many homes and lives could be lost. In addition, wind-blown embers from wildfires outside the community are a major concern. Additionally, wildfires burning excessive hazardous fuels is not conducive to resilient and functioning ecosystems.

Priority Landscape(s)

Funding and treatments were targeted for this area because it is the Sierra Front priority landscape in the Nevada Natural Resources Action Plan (http://www.stateforesters.org/forest-action-plans/nevada).
