To coordinate statewide efforts to value, conserve, manage, and enhance Nevada's community forests.

Strategic Plan Purpose

To clearly define our critical issues, strategic direction, and guidance for Nevada's Urban and Community Forestry Program Implementation.

Opportunities and Strategies to Improve Community Forest Management

Goal 1: Develop and maintain strong partnerships with key stakeholders that can contribute to urban and community forest planning including design, establishment, and maintenance (NUCFAC Goals: 1, 3, 5, 6, 7)

Strategy 1-1: Increase connections and partnerships to collaborate on Urban and Community Forestry program development and implementation

Performance Measure 1-1: Number of communities and partners engaged in Urban and Community Forestry programming and planning

Contributing Programs: NDF Natural Resource and Camp Programs, NDF Urban and Community Forestry Program (NDF UCF), International Society of Arboriculture, Local Tree Boards and Urban Forestry Commissions, Conservation Districts, Local and regional urban and community tree councils/organizations

Strategy 1-2: Continue engagement with the Western Urban and Community Forestry (WUCF) Network to stay current with emerging issues and maintain peer education opportunities

Strategy 1-3: Connect with HOAs, tree care companies, and municipalities to gather and disseminate inventory and forest health information

Strategy 1-4: Identify planners and create reference materials on the benefits of community trees that can influence multi-dimensional comprehensive plans (e.g. stormwater management plans, land use, green streets, downtown revitalization plans and others).

Goal 2: Promote the role of urban and community forestry in human health and wellness, local economies, ecosystem services, and urban livability (NUCFAC Goals: 2, 6)

Strategy 2-1: Expand opportunities and create connections for collaboration with the healthcare community by creating outreach/marketing materials for new audiences, including but not limited to hospitals, retirement homes, community centers, realtors, and the media. The focus for realtors could include information on how trees increase property values, how existing trees on a lot affect energy savings, and data on increased consumer spending in canopied areas.
