Fire Restrictions

All State Lands- including all Nevada State Park and Recreation Areas in Southern Nevada, Clark County: Old Las Vegas Mormon Fort, Valley of Fire, Spring Mountain Ranch, Ice Age Fossils and Big Bend of the Colorado SRA, Lincoln County: Elgin Schoolhouse, Kershaw Ryan, Cathedral Gorge, Echo Canyon, Spring Valley, Beaver Dam.

Nevada Division of Forestry's State Forester/Firewarden will impose the following fire restrictions for all State Lands, Nevada State Park and Recreation Areas listed above, pursuant to NRS 472.040, 472.510, 472.520 and 407.0475. Fire restrictions will be rescinded effective at **12:00 a.m., Monday November 25th, 2023.**
