Program Overview

The Nevada Division of Forestry, in partnership with the United States Forest Service, is proud to offer the 2026 Nevada Conservation Education Program Subgrant Award. This subgrant award offers funding for programs that serve the communities of Nevada through education for natural resource conservation, management, and protection. Applicants may request up to \$8,000 in funding to provide supplies, operating, and personnel expenses for a program that serves any age group up to two (2) years and focuses on the following Conservation Education objectives including but not limited to:

- Water Quality
- Fuels Reduction and Wildland Fire Safety
- Sustainable Natural Resource Management
- Soil Retention and Protection
- Invasive Species Management
- Erosion Prevention
- Wildlife Habitat Enhancement
- Native Species Encouragement
- Open Space Protection
- Sustainable Outdoor Recreation
- Ecological Identification

Application Process 2026

Applicants will read the terms and conditions below. Applicants must then fill out and submit the attached Intent to Apply to ndfstewardship@nv.forestry.gov by no later than March 1, 2026. Once the Intent to Apply is reviewed, the applicant must submit their grant proposal through Nevada ePro by April 30, 2026. Award decisions are anticipated to be announced in June of 2026.

Terms and Conditions

- Proposed purchases and budgets must follow the requirements outlined in the [Code of Federal Regulations, Title 2, Chapter 200: Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards](#) (2 CFR 200) and the [State Administrative Manual](#) (SAM).
- Priority consideration will be given to programs that serve rural Nevada communities (population under 20,000 residents), but all eligible applicants are encouraged to apply.
- Proposals must limit salary allocation to 50% or less of the overall project budget. Exception may be given for reasonable justification.
- Proposals may request up to the *de minimus* rate of 15% of the overall project budget if a Negotiated Indirect Cost Rate Agreement (NICRA) is not established. Back up documentation for NICRA will be required to be submitted.
- Applicants must provide a 20% nonfederal match in their submitted proposals.
- Applicants must be a registered Vendor with the State of Nevada. Please note that this is a different registration than NV ePRO. Please reach out to [Vendor Services](#) at vendordesk@sco.nv.gov to register or update your registration information with the State of Nevada.
- Applicants must be registered as a vendor in NV ePRO. Please note that this is a different registration than Vendor Registration with the State of Nevada. Applicants must ensure their account is associated with two (2) or more of the following National Institute of Governmental Purchasing (NIGP) Class Codes listed below. This ensures that grant correspondences in NV ePRO will reach your organization. Any relevant Class Item (suffix 2 digit code) under one of the main three (3) digit code (listed below) is permissible. - Applicants must ensure that their Federal System for Award Management ([SAM.gov](#)) registration is current and the information associated with their profile matches their information with Vendor Services through the State of Nevada, and NV ePro.
- **Prohibited Budget Items**
 - Food and drink may not be purchased
 - Travel must follow U.S. General Services Administration per diem and regulations. Travel must be in excess of 50 miles of the employee's base work location.
 - Capacity expansion is not permitted. Newly created positions for the grant program may not
