NOTICE OF WORKSHOP TO SOLICIT COMMENTS ON PROPOSED PERMANENT REGULATIONS

The Nevada Division of Forestry is proposing to repeal regulations pertaining to Chapter 527 of Nevada Administrative Code (NAC). A workshop has been set for:

The purpose of the workshop is to solicit oral and/or written comments from interested persons on updating the State's list of fully protected species of native flora. Specifically, the draft regulation adds Red Rock Sunflower (*Helianthus devernii*), known to exist in and around the Red Rock National Conservation Area in Clark County, Nevada, to the state list of fully protected species. The draft regulation also includes minor corrections to spelling and nomenclature for existing listed species as required by NAC 527.010(3).
